## Shays' Rebellion

## Daniel Shays'1786 Protest Against Economic and Civil Rights Injustices

Shays' Rebellion captured everyone's attention. Some, such as Thomas Jefferson, felt that "a little rebellion now and then is a good thing." But George Washington considered it a serious threat to the stability of a nascent country.

Daniel Shays was born in 1747 in Hopkinton, Mass. Multiple sources report his parents were Irish immigrants, other sources claim only his father was Irish born. It appears Shays was one of seven children and he grew up poor. Prior to the Revolutionary War, he worked as a farmhand in central Mass. In 1772 he married Abigail Gilbert and they had as many as ten children.

When the American Revolutionary War erupted, Shays joined the Continental Army and served first as a lieutenant in a Massachusetts regiment and later as a Captain. He fought at Bunker Hill and Saratoga, suffering non-life threatening wound. Shays was discharged in 1780 and settled in Pelham, Mass. His military background helped him win election to a series of local offices. Shays encountered disapproval from fellow veterans when he sold a ceremonial sword presented to him by the Marquis de Lafayette. He was not seeking to disrespect the legendary Frenchman's gift; he needed the money to pay down personal debts. At that time, there were many who shared Shays' financial woes.

The United States had beaten a superpower but faced colossal war-related debts. Debts accumulated at federal and state levels. Mass sought to mitigate its debt through rigorous taxation. Many felt these taxes were predatory, a sentiment especially acute among Revolutionary veterans. They were paid with paper currency which, due to inflation was now barely worth the paper on which it was printed.

Veterans had shed blood and devoted years of their lives to achieve independence. But, instead of benefiting from this sacrifice, they had to contend with financial exploitation. Many veterans and others began facing huge personal debts, confiscation of their properties, and even imprisonment. Prisons had more debtors for inmates than criminals.

Residents of western and central Massachusetts felt their best interests were excluded from the decision-making in Boston. Debates gave way to protests, which escalated to riots. As 1786 came to an end, the agitation reached a tipping point. Men from the western and central regions would comprise the majority of Shays' fellow rebels, known as "Shaysites". On Jan. 25, 1787, more than 1,000 Shaysites attacked the federal armory in Springfield. The Shaysites were outgunned by the state militia guarding the armory. The Shaysites may have had the moral high-ground, but they did not have superior weaponry. Shays' Rebellion met its demise at Petersham (Worcester County) on Feb. 4, 1787, when 3,000 soldiers funded largely by Boston businessmen defeated them resoundingly.

In the aftermath of this defeat, Mass authorities began seizing the ringleaders.

Shays fled to the backwoods of Vermont. Shaysites who absconded were tried in absentia; Shays and 17 others were sentenced to death.

Shays' Rebellion may have been a consideration for the framers of the U. S. Constitution composed the same year the insurrection was put down. The framers sought to strengthen the authority of the federal government, enhancing its ability to suppress similar revolts.

Shays relocated to New York State and lived a quiet life on a small farm. He never returned to Mass; however, the Commonwealth pardoned Shays in 1788. Shays' later years were lived in poverty. He died in Sparta, New York, on Sept. 29, 1825 at age 78. His name on the original tombstone was misspelled as "Shay." This error was corrected in 2016, when a descendant raised money for a new tombstone.

## New Concerns on Brexit Protocol on Northern Ireland

Under the terms of the BREXIT withdrawal agreement, a transition period ends on December 31. This is to allow for negotiations on a long-term trading relationship. If agreement cannot be reached, what is known as "a no-deal Brexit" will take effect on January 1, 2021.

The existing withdrawal agreement includes a **Northern Ireland protocol**. The six northern counties would effectively remain within the European single market, applying EU customs rules and product standards.

The 310-mile border between the two parts of Ireland is the only land border between the UK and the EU. During the BREXIT debate, concern was expressed that a "hard border" with customs posts at crossing-points would jeopardize the peace process.

Instead of a "hard border" on land, there would be a regulatory and customs border in the Irish Sea. Inevitably, some unionist politicians had concerns about the protocol which they felt was weakening the link between Northern Ireland and the rest of the UK.

The withdrawal agreement is an international treaty. Its terms take precedence over domestic legislation. But the UK proposed the *Internal Market Bill* which would allow the British to set aside certain provisions in the Northern Ireland protocol. [*The bill will be presented to the House of Commons on Tuesday 29 September 2020.*]

The Secretary of State for Northern Ireland, Brandon Lewis confirmed that the legislation would break international law in "a very specific and limited way". Legislation that would deliberately breach international law has caused shock even in conservative quarters in Britain. Five predecessors of current the Prime Minister Theresa May, Sir John Major, Tony Blair, Gordon Brown and David Cameron all criticized the proposed legislation. Ireland's Minister for Foreign Affairs Simon Coveney told Dáil Éireann: "Even if we get an agreement on a future relationship, I do not believe it will be ratified if there is still a threat by the UK to undermine the withdrawal agreement and break international law. Why would the EU ratify a new agreement with a country that is threatening to break an agreement that is not even 12 months old?"

During a US visit, UK Foreign Secretary Dominic Raab said: "What we cannot have is the EU seeking to erect a regulatory border down the Irish Sea between Northern Ireland and Britain."

After a meeting with Mr. Raab on Capitol Hill, with Speaker Nancy Pelosi and Chairman of the House Ways and Means Committee Congressman Richard Neal, stressed: there can be no bilateral trade agreement between the US and the UK if the Good Friday Agreement is under threat.

Speaker Pelosi said: "If Brexit undermines the Good Friday accord, there will be absolutely no chance of a US-UK trade agreement passing the Congress".

**Semi-formal/formal occasions**: the AOH "uniform" is green sport coat, tri-color sash, white shirt, Irish theme tie, black trousers and optional ball cap. These occasions include AOH State and National conventions, Masses, funerals, AOH dinners, parades, and other public events.

**Informal events** (i.e. Division outings (ball games, picnics, meetings, etc.) the division logo polo or sweatshirts (optional ball cap) are appropriate.

#### **Division Logo Items**:

**Green Jacket**: Brothers procure their own green jackets. One source: <u>http://blazerdepot.com/pages/mens\_blazer/augustagreenblazer.html</u>. Visit the website; call the 800 number; tell them you're with AOH and the \$5.00 small order fee can be waived. Kelly green is the color. **AOH Sash**: Brothers procure their own sashes. The AOH tri-color sash represents the national colors of Ireland and should be worn over the right shoulder (green closest to neck/collar) crossing to the left hip. Measure from right shoulder to left hip in inches; keep in mind the sash will normally be worn over a jacket, possibly a raincoat/overcoat (and maybe a growing waistline).
